Be it resolved to remove the following from the ALPS Constitution: (DO NOT REMOVE, AMEND INSTEAD)

2.3 OTHER INDIVIDUALS INTERESTED IN ALPS

Individuals who are not members of BCLA or Honorary members, but who identify themselves to the ALPS Executive in an appropriate manner may participate in meetings and workshops **at the non-member rate.** including free attendance to ALPS sponsored workshops when this workshop is available free to other ALPS members. Interested individuals may receive ALPS communications and minutes when these communications are distributed at functions that they attend. However, these individuals are not entitled to hold office, to vote on formal ALPS motions or issues, to receive financial reimbursement or members' preferential rates, or to other rights of members defined in the BCLA By-Laws.

Be it resolved to change the following sections to read as written below:

4.0 OFFICERS OF THE ORGANIZATION

4.1 The Officers of ALPS shall consist of the Chairperson, Chair-Elect, Recording Secretary, and two Continuing Education Coordinators (BCLA Continuing Education Committee Representative and BCLA Conference Program Committee Representative). The Officers will collectively be called the Executive. Active personal members of BCLA who are also members of ALPS may hold office.

5.0 TERMS OF OFFICE

5.4 The Education Coordinators (BCLA Continuing Education Committee Representative and BCLA Conference Program Committee Representative) shall serve two (2) year terms of office and may each

hold office for up to three consecutive terms.

7.0 DUTIES OF THE OFFICERS

7.4 Education Coordinators

The Education Coordinators shall review various programs and educational ideas and recommend these to the ALPS Executive for approval. The Education Coordinators may strike and will work with committee(s) to establish workshops and other educational activities and opportunities for members. The Education Coordinators will be ALPS' Educational Representatives to BCLA and work on corresponding BCLA committees. One Education Coordinator will be ALPS' representative to the Continuing Education Committee and the other Educational Coordinator will be ALPS' representative to the Conference Program Committee. The Education Coordinators will act as the Program Chair(s) for all ALPS workshops, providing program advertising and promotional information to facilitate publicity.
