ALS November 2015 survey results

- Majority support for including non-librarians
 - 53 (64.63%) agreed or strongly agreed with broadening the Section's mandate to include library personnel described as "non-librarian staff (e.g. technicians, assistants, archivists)
- Deprofessionalization
 - "More difficult to talk about deprofessionalization issues with technicians in the room."
 - This is worth addressing (and this is also a concern for technicians). However, this isn't in the scope of this working group (tasked with a proposed name change for inclusivity).

- Comments about Section focus
 - "I would prefer to see a functional focus return to our name and our gro[u]p [... W]e've watered the section down to the point that it's too broad to feel like a relevant home."
 - This is worth addressing; however, the concern about 'focus' could be separated from the discussion of job titles and education. Since the mandate of this WG is to address the inclusivity issue, then this is out of scope.

Current ALS by-laws

- The goals do not use language that is exclusive to librarians, but instead uses the phrase "library personnel."
- The purpose statement uses the term librarian.
- In the event of a name change, the purpose statement could be changed: to promote the exchange of ideas among academic library personnel-librarians and to provide a network of professional expertise resulting in excellent programs, initiatives and services in the post-secondary libraries of British Columbia, using the latest methods, systems and technologies."
- Can members attend and participate in meetings virtually? Can votes be taken electronically?
- A member is a BCLA member that has indicated interest in the Section by checking the box to join the Section in the myBCLA portal. Can this be more open?

PLIG name change update (sent to the BCLA Listserv Friday, Oct 7)

We are pleased to announce that PLIG's name has been changed to Public Libraries Interest Group. As you may know, we held a vote via an online survey tool this past week to change the name from Public Librarians Interest Group to Public Libraries Interest Group.

We had 81 responses to the survey – 74 (91.36%) in favour of the name change, and 7 (8.64%) against. [...]
