- Discussed a FNIG meeting at the conference where an election will be called for the executive roles. The nomination process for roles and individuals will be discussed at a future meeting.
- Action item: Sarah will send out to the list a call-out for 3 volunteers to put something together; hopefully an outline can be created for feedback by the next meeting.

### 4. Gene Joseph Scholarship Welcome Letter

- Minor edits on the GJS welcome letter, letter approved pending edits.
- General conversation took place inquiring about the details of the scholarship (how one applies, selection process, how to publicize, part-time student eligibility). We know that a student can apply or be nominated, but the rest is currently unknown. No policy intact right now for publicising recipient names. How to keep track of winners? And how (if) to publicize? Discussed reasons for public announcement to be on an opt-in basis to be sensitive to students' privacy. If we are going to make this public by default (opt-out policy), then we might want to notify applicants of this at the beginning of the application process. Need to table this until we can figure out the details.

Discussed the lack of response from library associations in Canada, and possible responses from related professional organisations (museums, archives). We discussed the need for FNIG to develop a statement on the TRC recommendations, and the need to develop a topic briefing to communicate the importance of reacting to the TRC recommendations for information professionals in BC.
