- 2. Truth and Reconciliation Canada activity update Sarah Dupont

- 3. Bella Bella library activities update Sarah Dupont
 - a. BCLA Statement
 The BCLA Statement was a success. Sarah has had interested librarians contact her for more information.
 - b. Sarah has been in contact with Bella Bella since our last Bella Bella working group meeting on July 25. She has discussed the possibility of partnering with Bella Bella to provide library support. We are waiting to hear back from Jessie Housty on Bella Bella's preferred modes of support.

- d. It seems Bella Bella has a mobile book storage unit in place for the processing of library materials. This was something FNIG had suggested we might aid in. With this need filled, we can focus our efforts on other means of support.

4. Gene Joseph Scholarship

- a. Awards: A successful candidate applied for the Gene Joseph Scholarship, receiving \$1500 for UBC.
- b. Disclosure: Questions arose regarding the disclosure/announcement of the recipient's name. Should disclosure be optional? Should it be included in the application forms? Is it possible to arrange confidentiality for recipients with UBC? It was proposed a working group should be developed to investigate these questions. Please respond to the email call for working groups if you are interested in participating in this effort.
- c. Fundraising: It was noted that having a list of recipients would be valuable in fundraising efforts.
- d. Membership: We also discussed encouraging group membership or participation of the award recipient not as obligatory participation, but as a welcoming invitation.
- e. Financials: We discussed arranging financial statements with UBC at the end of the fiscal year at March 31.
