- About practice, not theory. This is where the real learning happens - theory in action. It's not perfect and mistakes will happen. We learn from mistakes. Teachable moments to improve. This is not an exact science.

- Cross institutional approach, sharing expertise, causing primal shifts in communities.
- We have to be in the mess to understand the mess and find routes forward.

Other notes from discussions:

- How do we apply what we learn, talk about, experience, into practice? There is a disconnect between the training and theory and about how to apply the training and change the culture?
- How do we disable the biases that we come into readings, workshops, training? Using common experiences and language to allow us to connect and move forward.
- Didn't have to spend a huge amount of money. Create partnerships with the community to put best practices into action.
- Lack of reflection of diversity in library staffing at some public libraries. The library can be seen as a place of whiteness. What education requirements are barriers to diversifying the library workforce? We need to evaluate recruitment and how do we make the welcoming workplace truly welcoming?
- White fragility
- Literacy can be a barrier and an opportunity. What is the role of the library?
- We all have to participate. It is not just with on off training. It needs leadership, policy, front line staff, etc. to be involved.
- It is building relationships. We need to spend the time to participate and build relationships. We need to be asking the communities that are impacted.
- Change the question slightly to Which approach to anti-racism *learning* vs teaching do you think would be most effective?

The UBC Chapter of the BCLA had a meeting on Friday, 12 Feb 2021 to go over some active projects.

During Freedom to Read Week (21-27 Feb) we are planning to send out some informational emails to our mailing list about challenged books in BC and Canada, such as authors Robin Stevenson and Ivan Coyote.

The club has been expanding to include more members of the Young Adults and Children's Section (YAACS) which started a new reading group this week.

We are interested in compiling a list of librarians who would be comfortable with being contacted by students if they have questions about the field. The first step of this project is to establish a way of securely storing this information, though, which has not yet been finalised. The club executive would be responsible for mediating contact with students (i.e. the list would not be public). However we also know that librarians are working very hard right now so this is still very much a work in progress.

## 7. Roundtable

Adam - NWPL

- NWPL open to the public since August 2020. Looking into reintroducing loadable devices in March, planning the Lynda/LinkedIn Learning migration, and looking into expanding the opening hours for the public in the near future.
- Initiatives - revamps on website in response to pandemic, making eResource more accessible. Reorganizing navigation to be more user friendly
- Signage project - huge boost to New West as their walls used to be bare.

Richard - BPL

- BPL has a new public staffing model; clericals do some information services. More shifts as clerical to help patrons with basic information services.

- Librarians get more time to work more on projects.

Gillian - VPL

- VPL will be moving towards opening all branches to match as close as possible to pre-pandemic hours

- ORL had two FT Branch head positions opened, they may be filled in the near future.
- The City of Westbank is building their first city hall and Westbank library will build a new library in the same building.
