BCALS MEMBER SURVEY

Over summer 2019, the BCALS executive decided to conduct a membership survey to get a better sense of what they would like to see from the section. The survey went out to the BCALS listserv as well as the BCLA general list and we received 88 responses. 76% of respondents were current members of the BCALS listserv, 15% were not, and 8% were not sure. Roughly 60% of

respondents had attended a BCALS event in the past, with the December/Winter meeting being the most common (28% of all respondents), followed by the pub socials (12%).

We asked about what activities you would like to see from the BCALS. The top three results from this question were:

- 1) Greater use of the BCALS listserv for discussion or information sharing
- 2) Additional professional development events (in-person)
- 3) Additional professional development events (webinar or other online format)

Respondents identified many excellent themes or topics for future discussion including: indigenization; equity, diversity and inclusion; advocacy; work-life balance; information literacy and fake news; trends in research, scholarship and open access; copyright; privacy; and many more.

The executive chose to focus on greater use of the listserv, promoting professional development opportunities, particularly web-based ones as well as news from the section. We also made distance participation in the Winter Meeting a priority, accomplished by the use of community note taking and video recording the panel.

These priorities will continue to inform the BCALS executive in 2020-2021.

Student Representatives Report:

As student representatives for BCALS, part of our responsibility has been to manage BCALS' social media presence. We opted to come up with a strategy and reflect on how this was done previously. Our first proposed change was to stop using BCALS' designated Facebook page as it was a closed group and had little engagement and interaction with members. We decided Twitter was the most appropriate social media platform on which to focus and connect with the library community. We devised a plan to tweet on a regular basis with content pertaining to BCALS, BCLA, and general retweeting about the library world. Typically, we aimed to engage with the library community either once a week or every other week primarily by tweeting/retweeting relevant content and/or following and liking the content of the library community to ensure steady growth as well maintain BCALS' presence on the platform. Overall, we had a solid and consistent year given our size and target demographic. We saw an increase of about 42 followers for the year, and reached our initial goal of 300 by the end of summer. We started at around 270 and currently have a total of 312 followers. Despite seeing a minor slowdown in the winter months, we are pleased to report a modest growth over the year and have thoroughly enjoyed the experience.
