- <u>CFLA put forward a federal pre-budget ask</u>, working with CARL and CULC to identify consistent requests where they have shared interests, ensuring this year's submission is both unified with the other national library associations while also being unique to CFLA
- <u>Residential schools statement and press release</u> is coming highlights the need for truth before reconciliation, and calls for the sharing of documents held by government and church with families and communities
- There are plans to update the CFLA strategic plan before the February AGM
- New CFLA Board in February
- National Forum re-starts this year: 1 day themes are intellectual freedom and climate change; happening in May attached to Quebec Library Association Conference
