#### 6.0 President's Address and introduction to new BCLA President Shirley Lew (Anne Olsen)

Anne thanked the membership, the Board, and in particular, Daphne Wood and Todd Mundle.

Anne highlighted some of BCLA's achievements in 2017, including:

- Work on our bylaws has been ongoing. Bylaws have been updated so that they are aligned with stipulations in the new Society's Act. The bylaws will be presented to the membership at an upcoming AGM. Anne gave a special thank you to Annette DeFaveri for her tireless work on the bylaws.
- We finalized the partnership among the province's GLAM sector (galleries, libraries, archives, and museums), which resulted in a Memorandum of Understanding (MOU) – the first of its kind in Canada. The purpose of this MOU is to a) share professional expertise and knowledge in order to strengthen our capacity and reach; b) explore collaborative research and expand learning opportunities among members; c) identify joint funding ventures for projects of mutual interest, and d) consider new awards to acknowledge exceptional professionals and projects in our fields of expertise.
- Anne mentioned a number of committees that Board members participated in, including the committee that emerged from the CFLA's Truth and Reconciliation Committee, called Indigenous Matters, as well as the Intellectual Freedom and Copyright committees. She highlighted some of the work completed thus far, and work that will continue throughout 2018.
- Anne spoke to the the work done by the BC Digital Libraries Steering Committee, highlighting the value of this project in its purpose to advance access to intellectual, historical, and cultural records of British Columbia, and praising the strong model generated by this project team.
